

AMENDMENTS TO LB843

Introduced by Government, Military and Veterans Affairs.

1 1. Strike the original sections and insert the following new
2 sections:

3 Section 1. Section 17-503, Revised Statutes Cumulative Supplement,
4 2020, is amended to read:

5 17-503 (1) Except as provided in section 17-503.01, the power of any
6 city of the second class or village to convey any real property owned by
7 it, including land used for park purposes and public squares, except real
8 property used in the operation of public utilities, shall be exercised by
9 resolution directing the sale of such real property.

10 (2) After the passage of the resolution directing the sale, notice
11 of all proposed sales of property described in subsection (1) of this
12 section and the terms of such sales shall be published once each week for
13 three consecutive weeks in a legal newspaper in or of general circulation
14 in such city or village.

15 (3) If within thirty days after the third publication of the notice
16 a remonstrance petition against such sale (a) conforms to section 32-628,
17 (b) is signed by registered voters of the city or village equal in number
18 to thirty percent of the registered voters of the city or village voting
19 at the last regular municipal election held in such city or village, and
20 (c) is filed with the governing body of such city or village, such
21 property shall not then, nor within one year thereafter, be sold. If the
22 date for filing the petition falls upon a Saturday, Sunday, or legal
23 holiday, the signatures shall be collected within the thirty-day period,
24 but the filing shall be considered timely if filed or postmarked on or
25 before the next business day. Upon the receipt of the petition, the
26 governing body of such city or village, with the aid and assistance of
27 the election commissioner or county clerk, shall determine the validity

1 and sufficiency of signatures on the petition. The governing body of such
2 city or village shall deliver the petition to the election commissioner
3 or county clerk by hand carrier, by use of law enforcement officials, or
4 by certified mail, return receipt requested. Upon receipt of the
5 petition, the election commissioner or county clerk shall issue to the
6 governing body a written receipt that the petition is in the custody of
7 the election commissioner or county clerk. The election commissioner or
8 county clerk shall compare the signature of each person signing the
9 petition with the voter registration records to determine if each signer
10 was a registered voter on or before the date on which the petition was
11 filed with the governing body. The election commissioner or county clerk
12 shall also compare the signer's printed name, street and number or voting
13 precinct, and city, village, or post office address with the voter
14 registration records to determine whether the signer was a registered
15 voter. The signature and address shall be presumed to be valid only if
16 the election commissioner or county clerk determines that the printed
17 name, street and number or voting precinct, and city, village, or post
18 office address matches the registration records and that the registration
19 was received on or before the date on which the petition was filed with
20 the governing body. The determinations of the election commissioner or
21 county clerk may be rebutted by any credible evidence which the governing
22 body finds sufficient. The express purpose of the comparison of names and
23 addresses with the voter registration records, in addition to helping to
24 determine the validity of the petition, the sufficiency of the petition,
25 and the qualifications of the signer, shall be to prevent fraud,
26 deception, and misrepresentation in the petition process. Upon completion
27 of the comparison of names and addresses with the voter registration
28 records, the election commissioner or county clerk shall prepare in
29 writing a certification under seal setting forth the name and address of
30 each signer found not to be a registered voter and the signature page
31 number and line number where the name is found, and if the reason for the

1 invalidity of the signature or address is other than the nonregistration
2 of the signer, the election commissioner or county clerk shall set forth
3 the reason for the invalidity of the signature. If the election
4 commissioner or county clerk determines that a signer has affixed his or
5 her signature more than once to the petition and that only one person is
6 registered by that name, the election commissioner or county clerk shall
7 prepare in writing a certification under seal setting forth the name of
8 the duplicate signature and shall count only the earliest dated
9 signature. The election commissioner or county clerk shall certify to the
10 governing body the number of valid signatures necessary to constitute a
11 valid petition. The election commissioner or county clerk shall deliver
12 the petition and the certifications to the governing body within forty
13 days after the receipt of the petition from the governing body. The
14 delivery shall be by hand carrier, by use of law enforcement officials,
15 or by certified mail, return receipt requested. Not more than twenty
16 signatures on one signature page shall be counted.

17 The governing body shall, within thirty days after the receipt of
18 the petition and certifications from the election commissioner or county
19 clerk, hold a public hearing to review the petition and certifications
20 and receive testimony regarding them. The governing body shall, following
21 the hearing, vote on whether or not the petition is valid and shall
22 uphold the petition if sufficient valid signatures have been received.

23 (4) Real property now owned or hereafter owned by a city of the
24 second class or a village may be conveyed without consideration to the
25 State of Nebraska for state armory sites or, if acquired for state armory
26 sites, shall be conveyed strictly in accordance with the conditions of
27 sections 18-1001 to 18-1006.

28 (5) Following (a) passage of the resolution directing a sale, (b)
29 publishing of the notice of the proposed sale, and (c) passing of the
30 thirty-day right-of-remonstrance period, the property shall then be sold.
31 Such sale shall be confirmed by passage of an ordinance stating the name

1 of the purchaser and terms of the sale.

2 (6) Notwithstanding the procedures in subsections (1) through (5) of
3 this section, real property owned by a city of the second class or a
4 village may be conveyed when such property:

5 (a) Is sold in compliance with the requirements of federal or state
6 grants or programs;

7 (b) Is conveyed to another public agency; or

8 (c) Consists of streets and alleys.

9 Sec. 2. Section 32-101, Revised Statutes Cumulative Supplement,
10 2020, is amended to read:

11 32-101 Sections 32-101 to 32-1551 and sections 4, 5, 16, 30, 32, 39,
12 43, and 45 of this act shall be known and may be cited as the Election
13 Act.

14 Sec. 3. Section 32-103, Revised Statutes Cumulative Supplement,
15 2020, is amended to read:

16 32-103 For purposes of the Election Act, the definitions found in
17 sections 32-104 to 32-120 and sections 4 and 5 of this act shall be used.

18 Sec. 4. Emergency response provider shall mean a person responding
19 to a mutual aid agreement or a state of emergency proclamation issued by
20 the Governor or the President of the United States who is temporarily
21 assigned by a governmental or nongovernmental relief agency or employer
22 to provide support to victims of an emergency or a natural disaster or to
23 rebuild the infrastructure of an area affected by such emergency or
24 natural disaster.

25 Sec. 5. Political subdivision shall include a county, city,
26 village, township, school district, public power district, sanitary and
27 improvement district, metropolitan utilities district, rural or suburban
28 fire protection district, natural resources district, regional
29 metropolitan transit authority, community college, learning community
30 coordinating council, educational service unit, hospital district,
31 reclamation district, library board, airport authority, and any other

1 unit of local government of the State of Nebraska.

2 Sec. 6. Section 32-118, Reissue Revised Statutes of Nebraska, is
3 amended to read:

4 32-118 (1) Signature shall mean the name or symbol of a person
5 written with his or her own hand or the mark of a person unable to write
6 his or her name if the person's name is written by some other person and
7 the mark is made near the name by the person unable to write his or her
8 name.

9 (2) A person with a disability who by reason of that disability is
10 unable to write his or her name or symbol may substitute either:

11 (a) A mark if the person's name is written by some other person and
12 the mark is made near the name by the person unable to write his or her
13 name or symbol; or

14 (b) An impression made using a signature stamp. A signature stamp
15 shall be used only by that person or another person upon the request and
16 in the presence of the person unable to write his or her name or symbol.

17 (3) Any person rendering assistance to a person unable to write his
18 or her name or symbol shall write, next to such person's mark or
19 impression, the name and address of the person rendering assistance.

20 Sec. 7. Section 32-202, Revised Statutes Cumulative Supplement,
21 2020, is amended to read:

22 32-202 In addition to any other duties prescribed by law, the
23 Secretary of State shall:

24 (1) Supervise the conduct of primary and general elections in this
25 state;

26 (2) Provide training and support for election commissioners, county
27 clerks, and other election officials in providing for day-to-day
28 operations of the office, registration of voters, and the conduct of
29 elections;

30 (3) Enforce the Election Act;

31 (4) With the assistance and advice of the Attorney General, make

1 uniform interpretations of the act;

2 (5) Provide periodic training for the agencies and their agents and
3 contractors in carrying out their duties under sections 32-308 to 32-310;

4 (6) Develop and print forms for use as required by sections 32-308,
5 32-310, 32-320, 32-329, 32-947, 32-956, and 32-958;

6 (7) Contract with the Department of Administrative Services for
7 storage and distribution of the forms;

8 (8) Require reporting to ensure compliance with sections 32-308 to
9 32-310;

10 (9) Prepare and transmit reports as required by the National Voter
11 Registration Act of 1993, 52 U.S.C. 20501 et seq.;

12 (10) Develop and print a manual describing the requirements of the
13 initiative and referendum process and distribute the manual to election
14 commissioners and county clerks for distribution to the public upon
15 request;

16 (11) Develop and print pamphlets described in section 32-1405.01;

17 (12) Adopt and promulgate rules and regulations as necessary for
18 elections conducted under sections 32-952 to 32-959; and

19 (13) Establish a free access system, such as a toll-free telephone
20 number or an Internet website, that any voter who casts a provisional
21 ballot may access to discover whether the vote of that voter was counted
22 and, if the vote was not counted, the reason that the vote was not
23 counted. The Secretary of State shall establish and maintain reasonable
24 procedures necessary to protect the security, confidentiality, and
25 integrity of personal information collected, stored, or otherwise used by
26 the free access system. Access to information about an individual
27 provisional ballot shall be restricted to the individual who cast the
28 ballot.

29 Sec. 8. Section 32-203, Reissue Revised Statutes of Nebraska, is
30 amended to read:

31 32-203 In addition to any other powers prescribed by law, the

1 Secretary of State may:

2 (1) Inspect, with or without the filing of a complaint by any
3 person, and review the practices and procedures of election
4 commissioners, county clerks, their employees, and other election
5 officials in the day-to-day operations of the office, the conduct of
6 primary and general elections, and the registration of qualified
7 electors;

8 (2) Employ such personnel as necessary to efficiently carry out his
9 or her powers and duties as prescribed in the Election Act;

10 (3) Adopt and promulgate rules and regulations in regard to the
11 registration of voters and the conduct of elections; and

12 (4) Enforce the act by injunctive action brought by the Attorney
13 General in the district court for the county in which any violation of
14 the act occurs.

15 Sec. 9. Section 32-207, Reissue Revised Statutes of Nebraska, is
16 amended to read:

17 32-207 The office of election commissioner shall be created for each
18 county having a population of more than one hundred thousand inhabitants.
19 The election commissioner shall be appointed by the Governor and shall
20 serve for a term of four years or until a successor has been appointed
21 and qualified. In the event of a vacancy, the Governor shall appoint an
22 election commissioner to serve the unexpired portion of the term. In
23 order to further the purpose of fair and open elections free from outside
24 influence, the election commissioner shall have the duty of operational
25 and administrative oversight over the business of the office, subject to
26 review by the Secretary of State.

27 Sec. 10. Section 32-217, Reissue Revised Statutes of Nebraska, is
28 amended to read:

29 32-217 The election commissioner and ~~7~~ the chief deputy election
30 commissioner shall be county employees for the purposes of salary and
31 benefit plans. All ~~7~~ ~~and all~~ employees of the office of the election

1 commissioner shall be county employees and subject to the county
2 personnel system. The county board shall set the salaries of the election
3 commissioner and chief deputy election commissioner at least sixty days
4 prior to the expiration of the term of office of the election
5 commissioner holding office. The salary shall become effective as soon as
6 such salary may become operative under the Constitution of Nebraska.

7 In counties having a population of more than two hundred thousand
8 inhabitants, the salary of the election commissioner shall be at least
9 ten thousand five hundred dollars annually payable in periodic
10 installments out of the county general fund and the salary of the chief
11 deputy election commissioner shall be at least nine thousand dollars
12 annually payable in periodic installments out of the county general fund.

13 In counties having a population of more than one hundred fifty
14 thousand and not more than two hundred thousand inhabitants, the salary
15 of the election commissioner shall be at least seven thousand five
16 hundred dollars annually payable in periodic installments out of the
17 county general fund and the salary of the chief deputy election
18 commissioner shall be at least six thousand dollars annually payable in
19 periodic installments out of the county general fund.

20 In counties having a population of more than one hundred thousand
21 and not more than one hundred fifty thousand inhabitants, the salary of
22 the election commissioner shall be at least nine thousand five hundred
23 dollars annually payable in periodic installments out of the county
24 general fund and the salary of the chief deputy election commissioner
25 shall be at least eight thousand five hundred dollars annually payable in
26 periodic installments out of the county general fund.

27 In counties having a population of not more than one hundred
28 thousand inhabitants, the salary of the election commissioner shall be at
29 least six thousand five hundred dollars annually payable in periodic
30 installments out of the county general fund and the salary of the chief
31 deputy election commissioner shall be at least five thousand dollars

1 annually payable in periodic installments out of the county general fund.

2 Sec. 11. Section 32-221, Revised Statutes Cumulative Supplement,
3 2020, is amended to read:

4 32-221 (1) The election commissioner shall appoint precinct and
5 district inspectors, judges of election, and clerks of election to assist
6 the election commissioner in conducting elections on election day. In
7 counties with a population of less than four hundred thousand inhabitants
8 as determined by the most recent federal decennial census, judges and
9 clerks of election and inspectors shall be appointed at least thirty days
10 prior to the statewide primary election, shall hold office for terms of
11 two years or until their successors are appointed and qualified for the
12 next statewide primary election, and shall serve at all elections in the
13 county during their terms of office. In counties with a population of
14 four hundred thousand or more inhabitants as determined by the most
15 recent federal decennial census, judges and clerks of election shall be
16 appointed at least thirty days prior to the first election for which
17 appointments are necessary and shall serve for at least four elections.

18 (2) Judges and clerks of election may be selected at random from a
19 cross section of the population of the county. All qualified citizens
20 shall have the opportunity to be considered for service. All qualified
21 citizens shall fulfill their obligation to serve as judges or clerks of
22 election as prescribed by the election commissioner. No citizen shall be
23 excluded from service as a result of discrimination based upon race,
24 color, religion, sex, national origin, or economic status. No citizen
25 shall be excluded from service unless excused by reason of ill health or
26 other good and sufficient reason.

27 (3) All persons appointed shall be of good repute and character, be
28 able to read and write the English language, and except as otherwise
29 provided in subsections (4), (5), and (6) ~~subsection (4)~~ of section
30 32-223, be registered voters in the county. No candidate at an election
31 shall be appointed as a judge or clerk of election or inspector for such

1 election other than a candidate for delegate to a county, state, or
2 national political party convention.

3 (4) If a vacancy occurs in the office of judge or clerk of election
4 or inspector, the election commissioner shall fill such vacancy in
5 accordance with section 32-223. If any judge or clerk of election or
6 inspector fails to appear at the hour appointed for the opening of the
7 polls, the remaining officers shall notify the election commissioner,
8 select a registered voter to serve in place of the absent officer if so
9 directed by the election commissioner, and proceed to conduct the
10 election. If the election commissioner finds that a judge or clerk of
11 election or inspector does not possess all the qualifications prescribed
12 in this section or if any judge or clerk of election or inspector is
13 guilty of neglecting the duties of the office or of any official
14 misconduct, the election commissioner shall remove the person and fill
15 the vacancy.

16 Sec. 12. Section 32-223, Revised Statutes Cumulative Supplement,
17 2020, is amended to read:

18 32-223 (1) Except as otherwise provided in the Election Act, the
19 election commissioner shall appoint a precinct inspector and a receiving
20 board to consist of at least two judges and two clerks of election for
21 each precinct. The election commissioner may appoint district inspectors
22 to aid the election commissioner in the performance of his or her duties
23 and supervise a group of precincts on election day.

24 (2) The election commissioner may allow persons serving on a
25 receiving board as judges and clerks of election and precinct inspectors
26 to serve for part of the time the polls are open and appoint other judges
27 and clerks of election and precinct inspectors to serve on the same
28 receiving board for the remainder of the time the polls are open.

29 (3) On each receiving board at any one time, one judge and one clerk
30 of election shall be registered voters of the political party casting the
31 highest number of votes in the county for Governor or for President of

1 the United States in the immediately preceding general election, and one
2 judge and one clerk of election shall be registered voters of the
3 political party casting the next highest number of votes in the county
4 for Governor or for President of the United States in the immediately
5 preceding general election, except that one judge or clerk of election
6 may be a registered voter who is not affiliated with either of such
7 parties. If a third judge is appointed, such judge shall be a registered
8 voter of the political party casting the highest number of votes in the
9 county for Governor or for President of the United States in the
10 immediately preceding general election. All precinct and district
11 inspectors shall be divided between all political parties as nearly as
12 practicable in proportion to the number of votes cast in such county at
13 the immediately preceding general election for Governor or for President
14 of the United States by the parties, respectively.

15 (4) The election commissioner may appoint an elector residing
16 outside the county as a precinct inspector, district inspector, judge of
17 election, or clerk of election if the elector resides in a county which
18 conducts all elections by mail pursuant to section 32-960.

19 (5) If authorized by the Secretary of State and registered voters of
20 the county are unavailable, the election commissioner may appoint an
21 elector residing outside the county as a precinct inspector, district
22 inspector, judge of election, or clerk of election.

23 (6) {4} The election commissioner may appoint a person who is at
24 least sixteen years old but is not eligible to register to vote as a
25 clerk of election. Such clerk of election shall meet the requirements of
26 subsection (3) of section 32-221, except that such clerk shall not be
27 required to be a registered voter. No more than one clerk of election
28 appointed under this subsection shall serve at any precinct. A clerk of
29 election appointed under this subsection shall be considered a registered
30 voter who is not affiliated with a political party for purposes of this
31 section.

1 Sec. 13. Section 32-230, Revised Statutes Cumulative Supplement,
2 2020, is amended to read:

3 32-230 (1) As provided in subsection (4) of this section, the
4 precinct committeeman and committeewoman of each political party shall
5 appoint a receiving board consisting of three judges of election and two
6 clerks of election. The chairperson of the county central committee of
7 each political party shall send the names of the appointments to the
8 county clerk no later than February 1 prior to the primary election.

9 (2) If no names are submitted by the chairperson, the county clerk
10 shall appoint judges or clerks of election from the appropriate political
11 party. Judges and clerks of election may be selected at random from a
12 cross section of the population of the county. All qualified citizens
13 shall have the opportunity to be considered for service. All qualified
14 citizens shall fulfill their obligation to serve as judges or clerks of
15 election as prescribed by the county clerk. No citizen shall be excluded
16 from service as a result of discrimination based upon race, color,
17 religion, sex, national origin, or economic status. No citizen shall be
18 excluded from service unless excused by reason of ill health or other
19 good and sufficient reason.

20 (3) The county clerk may allow persons serving on a receiving board
21 to serve for part of the time the polls are open and appoint other
22 persons to serve on the same receiving board for the remainder of the
23 time the polls are open.

24 (4) In each precinct at any one time, one judge and one clerk of
25 election shall be appointed from the political party casting the highest
26 number of votes in the county for Governor or for President of the United
27 States in the immediately preceding general election, one judge and one
28 clerk shall be appointed from the political party casting the next
29 highest number of votes in the county for Governor or for President of
30 the United States in the immediately preceding general election, and one
31 judge shall be appointed from the political party casting the third

1 highest number of votes in the county for Governor or for President of
2 the United States in the immediately preceding general election. If the
3 political party casting the third highest number of votes cast less than
4 ten percent of the total vote cast in the county at the immediately
5 preceding general election, the political party casting the highest
6 number of votes at the immediately preceding general election shall be
7 entitled to two judges and one clerk.

8 (5) The county clerk may appoint registered voters to serve in case
9 of a vacancy among any of the judges or clerks of election or in addition
10 to the judges and clerks in any precinct when necessary to meet any
11 situation that requires additional judges and clerks. Such appointees may
12 include registered voters unaffiliated with any political party. Such
13 appointees shall serve at subsequent or special elections as determined
14 by the county clerk.

15 (6) The county clerk may appoint an elector residing outside the
16 county as a precinct inspector, district inspector, judge of election, or
17 clerk of election if the elector resides in a county which conducts all
18 elections by mail pursuant to section 32-960.

19 (7) If authorized by the Secretary of State and registered voters of
20 the county are unavailable, the county clerk may appoint an elector
21 residing outside the county as a precinct inspector, district inspector,
22 judge of election, or clerk of election.

23 (8) ~~(6)~~ The county clerk may appoint a person who is at least
24 sixteen years old but is not eligible to register to vote as a clerk of
25 election. Such clerk of election shall meet the requirements of
26 subsection (1) of section 32-231, except that such clerk shall not be
27 required to be a registered voter. No more than one clerk of election
28 appointed under this subsection shall serve at any precinct. A clerk of
29 election appointed under this subsection shall be considered a registered
30 voter who is not affiliated with a political party for purposes of this
31 section.

1 Sec. 14. Section 32-231, Revised Statutes Cumulative Supplement,
2 2020, is amended to read:

3 32-231 (1) Each judge and clerk of election appointed pursuant to
4 section 32-230 shall (a) be of good repute and character and able to read
5 and write the English language, (b) reside in the precinct in which he or
6 she is to serve unless necessity demands that personnel be appointed from
7 another precinct, (c) be a registered voter except as otherwise provided
8 in subsections (6), (7), and (8) ~~subsection (6)~~ of section 32-230, and
9 (d) serve for a term of two years or until judges and clerks of election
10 are appointed for the next primary election. No candidate at an election
11 shall be eligible to serve as a judge or clerk of election at the same
12 election other than a candidate for a delegate to a county, state, or
13 national political party convention.

14 (2) The county clerk may appoint district inspectors to aid the
15 county clerk in the performance of his or her duties and supervise a
16 group of precincts on election day. A district inspector shall meet the
17 requirements for judges and clerks of election as provided in subsection
18 (1) of this section, shall oversee the procedures of a group of polling
19 places, and shall act as the personal agent and deputy of the county
20 clerk. The district inspector shall ensure that the Election Act is
21 uniformly enforced at the polling places assigned to him or her and
22 perform tasks assigned by the county clerk. The district inspector may
23 perform all of the duties required of a judge or clerk of election.

24 Sec. 15. Section 32-235, Reissue Revised Statutes of Nebraska, is
25 amended to read:

26 32-235 (1) The county clerk shall, by mail, notify judges and clerks
27 of election, district inspectors, members of counting boards, and members
28 of canvassing boards of their appointment. The notice shall inform the
29 appointee of his or her appointment and of the date and time he or she is
30 required to report to the office of the county clerk or other designated
31 location and the polling place. The notice shall be mailed at least

1 fifteen days prior to each statewide primary and general election and on
2 or before the third Friday prior to each special election. The county
3 clerk shall order the members of the receiving board to appear at their
4 respective polling place on the day and at the hour specified in the
5 notice of appointment.

6 (2) Each appointee shall, at the time fixed in the notice of
7 appointment, report to the office or other location to complete any
8 informational forms and receive training regarding his or her duties. The
9 training shall include instruction as required by the Secretary of State
10 and any other training deemed necessary by the county clerk.

12 any person or organization distributing voter registration applications
13 by mail shall use the form prescribed by the Secretary of State. The form
14 shall contain on the top of the first page in bold type (a) the identity

17 This application was not sent from the Secretary of State or your
18 county election official.

19 You may submit this form if you wish to register to vote or update
20 your voter registration. You do not need to complete this form if you
21 have already registered to vote.

22 (2) This section shall not apply to voter registration applications
23 distributed by the Secretary of State, an election commissioner, a county
24 clerk, the State Department of Education, the Department of Health and
25 Human Services, or the Department of Motor Vehicles.

26 Sec. 17. Section 32-312, Revised Statutes Cumulative Supplement,
27 2020, is amended to read:

28 32-312 The registration application prescribed by the Secretary of
29 State pursuant to section 32-304 or 32-311.01 shall provide the
30 instructional statements and request the information from the applicant
31 as provided in this section.

1 CITIZENSHIP—"Are you a citizen of the United States of America?"
2 with boxes to check to indicate whether the applicant is or is not a
3 citizen of the United States.

4 AGE—"Are you at least eighteen years of age or will you be eighteen
5 years of age on or before the first Tuesday following the first Monday of
6 November of this year?" with boxes to check to indicate whether or not
7 the applicant will be eighteen years of age or older on election day.

8 WARNING—"If you checked 'no' in response to either of these
9 questions, do not complete this application."

10 NAME—the name of the applicant giving the first and last name in
11 full, the middle name in full or the middle initial, and the maiden name
12 of the applicant, if applicable.

13 RESIDENCE—the name and number of the street, avenue, or other
14 location of the dwelling where the applicant resides if there is a
15 number. If the registrant resides in a hotel, apartment, tenement house,
16 or institution, such additional information shall be included as will
