Summary of purpose and/or changes:

LB809, brought by Senator Moser, amends Section 71-5318, 71-5322, and 81-15,153, the Drinking Water State Revolving Fund Act and the Wastewater Treatment Facilities Construction Assistance Act to better align the funds with existing federal regulation, and new provisions of the Infrastructure Investment and Jobs Act. The Acts provides low interest loans and small community matching grants to municipalities for construction of wastewater treatment facilities and sanitary sewer collection systems to alleviate public health and environmental problems in accordance with the federal Safe Drinking Water Act.

Currently, the Fund can be used to pay or to secure the payment of bonds. LB809 adds authority to buy or refinance the debt obligation of any municipality for a public water supply system if the debt was incurred for the system and construction on the system began after July 1, 1993 and raises the allowable amount of forgiveness from fifty to seventy-five percent.

Sec. 1 Amends 71-5318 to allow funds to be used to purchase or refinancing debt obligations.

Sec. 2 Amends section 71-5322(9) to increase grant and loan forgiveness from fifty to seventy-five percent of project costs for eligible projects related to public water systems that serve ten thousand persons or less. Extends funding for lead service line replacement projects in accordance with federal regulatory and statutory provisions.

Sec. 3 Amends 81-15,153 to add "loan forgiveness" and to allow for increased percentage.

Explanation of amendments:

AM 2004 incorporates the provisions of three other related bills into the bill: LB 924, LB 978, and LB 803 (as amended by AM 1912).

The Committee voted to adopt AM 2004 on a 7-0 vote.

LB924 amends Section 81-15,160 (2) of the Waste Reduction and Recycling Incentive Act to allow participation in grants for reimbursement costs of projects under the act by cities of the first class if the projects otherwise meet the criterion of the Act.

LB803 amends section 37-455 to expand the definition of immediate family member of a landowner or leaseholder to include grandchildren and step grandchildren and their spouses for the purpose of being eligible for special hunting permits as the immediate family of a qualified landowner. The bill also increases the number of total permits and youth permits that

can be issued. As amended, the bill permits eight total permits to be issued, two to adults over 19 years, and up to six for youth.

Sec.1 LB803 (Hughes) amends section 37-455 to add grandchildren and step-grandchildren to definition of immediate family members for purposes of limited hunting permits.

Sec.2 through Sec. 3 LB809 (Moser) amends sections 71-5318 and 71-5322 the Drinking Water State Revolving Fund Act and the Wastewater Treatment Facilities Construction Assistance Act to better align the funds with existing federal regulation, and new provisions of the Infrastructure Investment and Jobs Act.

Sec.4 through Sec. 9 LB978 (Hughes) LB978, amends Nebraska's Environmental Protection Act found in Sections 81-1501 to 81-1532 to take the next step to the state to administer the federal dredge and fill permit program (404 permit program).

Sec.11 LB924 (Brewer) amends 81-15,160 to add cities of the first class as eligible for grants to reimburse costs of reclamation of certain materials from abandoned buildings.
