Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill establishes requirements for a resident dental license. The amendment adds language in Sec. 2 regarding exam requirements, specifying that applicants must pass a jurisprudence examination based on Nebraska Law and administrative rules and regulations pertaining to dentistry and dental hygiene in order to qualify.

There is no fiscal impact to Nebraska State Patrol. The Department of Health and Human Services would be able to recover any increased administrative costs via fees. No additional funding or spending authority would be needed to implement the changes.

LB 834 changes the title of existing “Temporary” Dental license to read “Resident” Dental license, but also changes the requirements for issuance.

The Department of Health and Human Services (DHHS) would perform the additional work needed to implement LB 834, including, updates to rules and regulations, modifications to the licensure software system; application form changes; and DHHS website information changes.

All costs associated with implementing and administering LB 834 will be recovered under the Uniform Credentialing Act Sections 38-151 through 38-156, administrative costs and fees.
