LB 894 is amended to require any candidate that runs for the office of sheriff to possess a law enforcement officer certificate or diploma. The director of the Nebraska Law Enforcement Training Center must certify that the candidate was issued a certificate or diploma.

AM2370 replaces the original bill and incorporates provisions for situations where a vacancy occurs in the office of an elected county sheriff. Additionally, it removes the grace period previously allowed for candidates for the office of sheriff to acquire a certificate or diploma from the Nebraska Law Enforcement Training Center.

AM2764 will allow individuals granted Deferred Action for Childhood Arrival (DACA) status to receive law enforcement training and certification.

There is no fiscal impact to the state.

Explanation of Estimate:

LB 894, AM2370 replaces the original bill and includes provisions in the event there is a vacancy in the office of elected county sheriff. Additionally, it eliminates a grace period for any candidate for the office of sheriff to obtain a certificate or diploma from the Nebraska Law Enforcement Training Center.

AM2764 will permit individuals who have received Deferred Action for Childhood Arrival status to receive law enforcement training and certification.

There is expected to be no fiscal impact or a minimal one.
