## **LEGISLATIVE BILL 208**

- 1 A BILL FOR AN ACT relating to counties; to define a term; to prohibit a
- 2 county from prohibiting the use of property as a short-term rental
- as prescribed; to provide for regulation of short-term rentals; and
- 4 to provide a duty for the Revisor of Statutes.
- 5 Be it enacted by the people of the State of Nebraska,

LB208 2023

- 1 Section 1. (1) For purposes of this section, short-term rental
- 2 means a residential property, including a single-family dwelling or a
- 3 unit in a condominium, cooperative, or time-share, that is rented wholly
- 4 or partly for a fee for a period not longer than thirty consecutive days.
- 5 (2) Except as provided in subsection (5) of this section, a county
- 6 shall not adopt or enforce an ordinance, resolution, or other regulation
- 7 that expressly or effectively prohibits the use of a property as a short-
- 8 <u>term rental.</u>
- 9 (3) A county may adopt or enforce an ordinance, resolution, or other
- 10 regulation that specifically regulates property used as a short-term
- 11 <u>rental only if the county demonstrates that the primary purpose of the</u>
- 12 <u>ordinance</u>, <u>resolution</u>, <u>or other regulation is to protect the public's</u>
- 13 <u>health and safety. An ordinance, resolution, or other regulation</u>
- 14 <u>authorized by this subsection includes:</u>
- 15 (a) Requirements addressing:
- (i) Fire and building codes;
- 17 (ii) Health and sanitation;
- 18 (iii) Traffic control; and
- 19 (iv) Solid or hazardous waste and pollution control; and
- 20 (b) Requirements regarding the designation of an emergency contact
- 21 <u>for the property.</u>
- 22 (4) A county may adopt or enforce an ordinance, resolution, or other
- 23 regulation that imposes a sales tax or an occupation tax on short-term
- 24 <u>rentals if the tax is otherwise permitted by applicable law.</u>
- 25 (5) A county may adopt or enforce an ordinance, resolution, or other
- 26 regulation that limits or prohibits the use of a short-term rental only
- 27 <u>if the law limits or prohibits the use of a short-term rental for the</u>
- 28 purpose of:
- 29 <u>(a) Housing sex offenders;</u>
- 30 (b) Operating a structured sober living home or similar enterprise;
- 31 (c) Selling illegal drugs;

1 (d) Selling alcohol or another activity that requires a permit or

- 2 <u>license under the Nebraska Liquor Control Act; or</u>
- 3 (e) Operating a sexually oriented business.
- 4 (6) A county shall apply an ordinance, resolution, or other
- 5 <u>regulation regulating land use to a short-term rental in the same manner</u>
- 6 as another similar property. An ordinance, resolution, or other
- 7 regulation described by this subsection includes:
- 8 (a) Residential use and other zoning matters;
- 9 (b) Noise and other nuisances; and
- 10 (c) Property maintenance.
- 11 (7) This section shall not be construed to affect regulations of a
- 12 private entity, including a homeowners association organized under the
- 13 <u>Condominium Property Act or the Nebraska Condominium Act.</u>
- 14 Sec. 2. The Revisor of Statutes shall assign section 1 of this act
- 15 to Chapter 23.
