1 A BILL FOR AN ACT relating to government; to amend sections 32-311.01, 2 32-321, 32-808, 32-914, 32-938, 32-941, 32-942, 32-943, 32-944, 3 39-1601, 39-1605, 39-1606, 60-484, and 71-612, Reissue Revised 4 Statutes of Nebraska, and sections 32-101, 32-103, 32-202, 32-221, 32-223, 32-230, 32-231, 32-559, 32-803, 32-908, 32-915, 32-939, 5 6 32-939.02, 32-947, 32-950.01, 32-1002, 32-1027, and 60-4,115, 7 Revised Statutes Cumulative Supplement, 2022; to require qualifying photographic identification for voter registration and voting 8 purposes; to change provisions relating to elections; to eliminate 9 the fee for certain state identification cards and certified copies 10 eliminate certain 11 certificates; to identification requirements and provisions regarding conducting elections by mail; 12 13 to harmonize provisions; to repeal the original sections; to 14 outright repeal sections 32-110.02, 32-953, 32-954, 32-957, 32-958, 15 32-959, and 32-1551, Reissue Revised Statutes of Nebraska, sections 32-110.03, 32-318.01, 32-939.03, 32-952, 32-956, 16 32-960, Revised Statutes Cumulative Supplement, 2022; and to declare 17 18 an emergency.

- 14 (3) A United States Passport that is not expired or has been expired
- 15 less than sixty days; or
- 16 (4) A valid tribal identification issued by a recognized Indian
- 17 tribe.

- 19 2022, is amended to read:
- 20 32-202 In addition to any other duties prescribed by law, the
- 21 Secretary of State shall:
- 22 (1) Supervise the conduct of primary and general elections in this
- 23 state;
- 24 (2) Provide training and support for election commissioners, county
- 25 clerks, and other election officials in providing for day-to-day
- 26 operations of the office, registration of voters, and the conduct of
- 27 elections;
- 28 (3) Enforce the Election Act;
- 29 (4) With the assistance and advice of the Attorney General, make

- 25 used by the free access system. Access to information about an individual

- 27 ballot.
- 28 Sec. 5. Section 32-221, Revised Statutes Cumulative Supplement,
- 29 2022, is amended to read:
- 30 32-221 (1) The election commissioner shall appoint precinct and
- 31 district inspectors, judges of election, and clerks of election to assist

1 the election commissioner in conducting elections on election day. In 2 counties with a population of less than four hundred thousand inhabitants as determined by the most recent federal decennial census, judges and 3 4 clerks of election and inspectors shall be appointed at least thirty days prior to the statewide primary election, shall hold office for terms of 5 two years or until their successors are appointed and qualified for the 6 next statewide primary election, and shall serve at all elections in the 7 county during their terms of office. In counties with a population of 8 9 four hundred thousand or more inhabitants as determined by the most recent federal decennial census, judges and clerks of election shall be 10 appointed at least thirty days prior to the first election for which 11 appointments are necessary and shall serve for at least four elections. 12

- (2) Judges and clerks of election may be selected at random from a 13 cross section of the population of the county. All qualified citizens 14 shall have the opportunity to be considered for service. All qualified 15 16 citizens shall fulfill their obligation to serve as judges or clerks of 17 election as prescribed by the election commissioner. No citizen shall be excluded from service as a result of discrimination based upon race, 18 color, religion, sex, national origin, or economic status. No citizen 19 shall be excluded from service unless excused by reason of ill health or 20 other good and sufficient reason. 21
- 22 (3) All persons appointed shall be of good repute and character, be
  23 able to read and write the English language, and except as otherwise
  24 provided in subsections (4) and  $_{7}$  (5), and (6) of section 32-223, be
  25 registered voters in the county. No candidate at an election shall be
  26 appointed as a judge or clerk of election or inspector for such election
  27 other than a candidate for delegate to a county, state, or national
  28 political party convention.
- (4) If a vacancy occurs in the office of judge or clerk of election or inspector, the election commissioner shall fill such vacancy in accordance with section 32-223. If any judge or clerk of election or

- 1 inspector fails to appear at the hour appointed for the opening of the
- 2 polls, the remaining officers shall notify the election commissioner,
- 3 select a registered voter to serve in place of the absent officer if so
- 4 directed by the election commissioner, and proceed to conduct the
- 5 election. If the election commissioner finds that a judge or clerk of
- 6 election or inspector does not possess all the qualifications prescribed
- 7 in this section or if any judge or clerk of election or inspector is
- 8 guilty of neglecting the duties of the office or of any official
- 9 misconduct, the election commissioner shall remove the person and fill
- 10 the vacancy.
- 11 Sec. 6. Section 32-223, Revised Statutes Cumulative Supplement,
- 12 2022, is amended to read:
- 13 32-223 (1) Except as otherwise provided in the Election Act, the
- 14 election commissioner shall appoint a precinct inspector and a receiving
- 15 board to consist of at least two judges and two clerks of election for
- 16 each precinct. The election commissioner may appoint district inspectors
- 17 to aid the election commissioner in the performance of his or her duties
- 18 and supervise a group of precincts on election day.
- 19 (2) The election commissioner may allow persons serving on a
- 20 receiving board as judges and clerks of election and precinct inspectors
- 21 to serve for part of the time the polls are open and appoint other judges
- 22 and clerks of election and precinct inspectors to serve on the same
- 23 receiving board for the remainder of the time the polls are open.
- 24 (3) On each receiving board at any one time, one judge and one clerk
- 25 of election shall be registered voters of the political party casting the
- 26 highest number of votes in the county for Governor or for President of
- 27 the United States in the immediately preceding general election, and one
- 28 judge and one clerk of election shall be registered voters of the
- 29 political party casting the next highest number of votes in the county
- 30 for Governor or for President of the United States in the immediately
- 31 preceding general election, except that one judge or clerk of election

- 1 may be a registered voter who is not affiliated with either of such
- 2 parties. If a third judge is appointed, such judge shall be a registered
- 3 voter of the political party casting the highest number of votes in the
- 4 county for Governor or for President of the United States in the
- 5 immediately preceding general election. All precinct and district
- 6 inspectors shall be divided between all political parties as nearly as
- 7 practicable in proportion to the number of votes cast in such county at
- 8 the immediately preceding general election for Governor or for President
- 9 of the United States by the parties, respectively.
- 10 (4) The election commissioner may appoint an elector residing
- 11 outside the county as a precinct inspector, district inspector, judge of
- 12 election, or clerk of election if the elector resides in a county which
- 13 conducts all elections by mail pursuant to section 32-960.
- 14 (4) (5) If authorized by the Secretary of State and registered
- 15 voters of the county are unavailable, the election commissioner may
- 16 appoint an elector residing outside the county as a precinct inspector,
- 17 district inspector, judge of election, or clerk of election.
- 18 (5) (6) The election commissioner may appoint a person who is at
- 19 least sixteen years old but is not eligible to register to vote as a
- 20 clerk of election. Such clerk of election shall meet the requirements of
- 21 subsection (3) of section 32-221, except that such clerk shall not be
- 22 required to be a registered voter. No more than one clerk of election
- 23 appointed under this subsection shall serve at any precinct. A clerk of
- 24 election appointed under this subsection shall be considered a registered
- 25 voter who is not affiliated with a political party for purposes of this
- 26 section.
- 27 Sec. 7. Section 32-230, Revised Statutes Cumulative Supplement,
- 28 2022, is amended to read:
- 29 32-230 (1) As provided in subsection (4) of this section, the
- 30 precinct committeeman and committeewoman of each political party shall
- 31 appoint a receiving board consisting of three judges of election and two

clerks of election. The chairperson of the county central committee of each political party shall send the names of the appointments to the county clerk no later than February 1 prior to the primary election.

- 4 (2) If no names are submitted by the chairperson, the county clerk 5 shall appoint judges or clerks of election from the appropriate political party. Judges and clerks of election may be selected at random from a 6 7 cross section of the population of the county. All qualified citizens shall have the opportunity to be considered for service. All qualified 8 9 citizens shall fulfill their obligation to serve as judges or clerks of election as prescribed by the county clerk. No citizen shall be excluded 10 from service as a result of discrimination based upon race, color, 11 religion, sex, national origin, or economic status. No citizen shall be 12 excluded from service unless excused by reason of ill health or other 13 good and sufficient reason. 14
- (3) The county clerk may allow persons serving on a receiving board to serve for part of the time the polls are open and appoint other persons to serve on the same receiving board for the remainder of the time the polls are open.
- (4) In each precinct at any one time, one judge and one clerk of 19 election shall be appointed from the political party casting the highest 20 number of votes in the county for Governor or for President of the United 21 States in the immediately preceding general election, one judge and one 22 clerk shall be appointed from the political party casting the next 23 24 highest number of votes in the county for Governor or for President of 25 the United States in the immediately preceding general election, and one judge shall be appointed from the political party casting the third 26 highest number of votes in the county for Governor or for President of 27 28 the United States in the immediately preceding general election. If the political party casting the third highest number of votes cast less than 29 ten percent of the total vote cast in the county at the immediately 30 preceding general election, the political party casting the highest 31

- 1 number of votes at the immediately preceding general election shall be
- 2 entitled to two judges and one clerk.
- 3 (5) The county clerk may appoint registered voters to serve in case
- 4 of a vacancy among any of the judges or clerks of election or in addition
- 5 to the judges and clerks in any precinct when necessary to meet any
- 6 situation that requires additional judges and clerks. Such appointees may
- 7 include registered voters unaffiliated with any political party. Such
- 8 appointees shall serve at subsequent or special elections as determined
- 9 by the county clerk.
- 10 (6) The county clerk may appoint an elector residing outside the
- 11 county as a precinct inspector, district inspector, judge of election, or
- 12 clerk of election if the elector resides in a county which conducts all
- 13 elections by mail pursuant to section 32-960.
- 14 (6) (7) If authorized by the Secretary of State and registered
- 15 voters of the county are unavailable, the county clerk may appoint an
- 16 elector residing outside the county as a precinct inspector, district
- 17 inspector, judge of election, or clerk of election.
- 18 (7) (8) The county clerk may appoint a person who is at least
- 19 sixteen years old but is not eligible to register to vote as a clerk of
- 20 election. Such clerk of election shall meet the requirements of
- 21 subsection (1) of section 32-231, except that such clerk shall not be
- 22 required to be a registered voter. No more than one clerk of election
- 23 appointed under this subsection shall serve at any precinct. A clerk of

- 27 Sec. 8. Section 32-231, Revised Statutes Cumulative Supplement,
- 28 2022, is amended to read:
- 29 32-231 (1) Each judge and clerk of election appointed pursuant to
- 30 section 32-230 shall (a) be of good repute and character and able to read
- 31 and write the English language, (b) reside in the precinct in which he or

- 1 she is to serve unless necessity demands that personnel be appointed from
- 2 another precinct, (c) be a registered voter except as otherwise provided
- 3 in subsections (6) and  $_{7}$  (7), and (8) of section 32-230, and (d) serve
- 4 for a term of two years or until judges and clerks of election are
- 5 appointed for the next primary election. No candidate at an election
- 6 shall be eligible to serve as a judge or clerk of election at the same

- 21 32-311.01 (1) The Secretary of State shall prescribe and distribute
- 22 a registration application which may be used statewide to register to
- 23 vote and update voter registration records. An applicant may use the
- 24 application to register to vote or to update his or her voter
- 25 registration record with changes in his or her personal information or
- 26 other information related to his or her eligibility to vote. An applicant
- 27 may submit the application in person, through a personal messenger or
- 28 personal agent, or by mail. Every election commissioner or county clerk
- 29 shall accept such an application for registration and shall require the
- 30 voter to present, personally or by messenger or personal agent, a

- 11 registering in the state for the first time and has not previously voted
- 12 within the state, the applicant must submit with the application a color
- 13 copy of a qualifying photographic photo identification which is current
- 14 and valid or a copy of a utility bill, bank statement, government check,
- 15 paycheck, or other government document that is current and that shows the
- 16 name and address of the applicant as they appear on the application in
- 17 order to avoid additional identification requirements when voting for the
- 18 first time;
- 19 (c) An applicant may deliver the application to the office of the
- 20 election commissioner or county clerk in person, through a personal
- 21 messenger or personal agent, or by mail;
- (d) To vote at the polling place on election day, the completed
- 23 application must be:
- 24 (i) Delivered by the applicant in person to the office of the
- 25 election commissioner or county clerk on or before the deadline
- 26 prescribed in section 32-302;
- 27 (ii) Delivered by the applicant's personal messenger or personal
- 28 agent to the office of the election commissioner or county clerk on or
- 29 before the third Friday before the election; or
- 30 (iii) Postmarked on or before the third Friday before the election
- 31 if the application is submitted by mail; and

- (e) The election commissioner or county clerk will, upon receipt of the application for registration, send an acknowledgment of registration to the applicant indicating whether the application is proper or not.
- Sec. 10. Section 32-321, Reissue Revised Statutes of Nebraska, is amended to read:
- 6 32-321 (1) Any elector may request a voter registration application from the office of the Secretary of State or the election commissioner or 7 county clerk. The Secretary of State and the election commissioner or 8 9 county clerk shall make registration applications prescribed by the Secretary of State available and may place the applications in public 10 places. The Secretary of State and the election commissioner or county 11 clerk may require that all unused applications be returned to his or her 12 office and may place reasonable limits on the amount of applications 13 requested. 14
- (2) If an elector returns the completed application to the office of 15 16 the Secretary of State or submits an application to the Secretary of 17 State pursuant to section 32-304, the office shall deliver the application to the election commissioner or county clerk of the county in 18 which the elector resides not later than ten days after receipt by the 19 office, except that if the application is returned to the office or 20 submitted pursuant to section 32-304 within five days prior to the third 21 Friday preceding any election, it shall be delivered not later than five 22 23 days after the date it is returned. The deadline for returning a 24 completed application to the office of the Secretary of State or 25 submitting an application pursuant to section 32-304 is the close of business on the third Friday preceding an election to be registered to 26 vote at such election. A registration application received after the 27 28 deadline shall not be processed by the election commissioner or county clerk until after the election. The office of the Secretary of State 29 shall be a designated voter registration agency for purposes of section 7 30 of the National Voter Registration Act of 1993, 42 U.S.C. 1973gg-5, as 31

- 1 such section existed on March 11, 2008.
- 2 (3) If an elector mails the registration application to the election
- 3 commissioner or county clerk:
- 4 (a)(i) The application shall be postmarked on or before the third
- 5 Friday before the next election; or
- 6 (ii) The application shall be received not later than the second
- 7 Tuesday before the next election if the postmark is unreadable; and
- 8 (b) The application shall be processed by the election office as a
- 9 proper registration for the voter to be entitled to vote on the day of
- 10 the next election.
- 11 (4) If the registration application arrives after the registration
- 12 deadline, the application shall not be processed until after the
- 13 election. Written notice shall be given to any applicant whose
- 14 registration application failed to meet the registration deadline or was
- 15 found to be incorrect or incomplete and shall state the specific reason
- 16 for rejection. If the application is incomplete, the election
- 17 commissioner or county clerk shall notify the applicant of the failure to
- 18 provide the required information, including failure to provide qualifying
- 19 <u>photographic</u> identification if required, and provide the applicant with
- 20 the opportunity to submit <u>a qualifying photographic</u> <del>an</del> identification
- 21 document as described in section 32-318.01 prior to the deadline for
- 22 voter registration or to complete and submit a corrected registration
- 23 application in a timely manner to allow for the proper registration of
- 24 the applicant prior to the next election. All postage costs related to
- 25 returning registration applications to the election commissioner or
- 26 county clerk shall be paid by the registrant.
- 27 Sec. 11. Section 32-559, Revised Statutes Cumulative Supplement,
- 28 2022, is amended to read:
- 29 32-559 (1)(a) Except as provided in section 77-3444, any issue to be
- 30 submitted to the registered voters at a special election by a political
- 31 subdivision shall be certified by the clerk of the political subdivision

1 to the election commissioner or county clerk on or before the eighth

- 2 Friday prior to the election. A special election may be held by mail as
- 3 provided in sections 32-952 to 32-959. Any other special election under
- 4 this section shall be subject to section 32-405.
- 5 (b) In lieu of submitting the issue at a special election, any political subdivision may submit the issue at a statewide primary or 6 general election or at any scheduled county election, except that no such 7 issue shall be submitted at a statewide election or scheduled county 8 9 election unless the issue to be submitted has been certified by the clerk of the political subdivision to the election commissioner or county clerk 10 by March 1 for the primary election and by September 1 for the general 11 election. Upon completion of the canvass of the vote by the county canvassing board, the election commissioner or 25 county clerk shall certify the election results to the governing body of 26 the political subdivision. The canvass by the county canvassing board 27 28 shall have the same force and effect as if made by the governing body of the political subdivision. 29
  - (2)(a) A political subdivision that has submitted an issue for a special election under subdivision (1)(a) of this section may cancel the

- 1 special election if the Secretary of State, election commissioner, or
- 2 county clerk receives a resolution adopted by the political subdivision
- 3 canceling the special election on or before the fourth Thursday prior to
- 4 the election. No cancellation shall be effective after such date. If a

- 24 or village board. The sample shall be printed in English and in any other
- 25 language required pursuant to the Voting Rights Language Assistance Act

- 27 (2) Such Except for elections conducted in accordance with section
