1 A BILL FOR AN ACT relating to veterans; to amend sections 80-401.03,
2 80-401.11, and 80-412, Reissue Revised Statutes of Nebraska, and
3 sections 80-315, 80-411, and 81-1316, Revised Statutes Cumulative
4 Supplement, 2022; to change references to a veterans' home; to
5 change provisions relating to veterans aid, Department of Veterans'
6 Affairs offices, and duties of the Director of Veterans' Affairs; to
7 eliminate an obsolete provision; to repeal the original sections;
8 and to outright repeal section 80-336, Revised Statutes Cumulative
9 Supplement, 2022.

10 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 80-315, Revised Statutes Cumulative Supplement,
2 2022, is amended to read:

3 80-315 The Central Nebraska Grand Island ~~Grand Island~~ Veterans' Home, the Norfolk
4 Veterans' Home, the Eastern Nebraska Veterans' Home, and the Western
5 Nebraska Veterans' Home are established. The State of Nebraska shall
6 maintain the homes as provided in the Nebraska Veterans Services Act.

7 Sec. 2. Section 80-401.03, Reissue Revised Statutes of Nebraska, is
8 amended to read:

9 80-401.03 (1) The Director of Veterans' Affairs shall be responsible
10 for the administration of the income funds from the Nebraska Veterans'
11 Aid Fund for the aid of needy veterans and their dependents.

12 (2) The Director of Veterans' Affairs ~~director~~, the deputy director,
13 or a designee of the director shall receive and approve for payment or
14 disapprove applications for aid which shall originate in any local post
15 of any recognized veterans organization or with a county veterans service
16 officer. ~~Any person eligible for such aid shall make application for the~~
17 ~~same through such local post or county veterans service officer in the~~
18 ~~community nearest his or her place of residence.~~ If there are two or more
19 local posts of one or more recognized veterans organizations in any
20 community, no claimant can originate a claim in more than one such post
21 at any given time and a period of at least thirty days shall elapse
22 between the filing of claims. An application shall not be deemed to be
23 filed until it has been received and filed in the office of the Director
24 of Veterans' Affairs. The director may adopt and promulgate such rules
25 and regulations as may be necessary for administering such aid.

26 (3) No part of the interest accumulation of the Nebraska Veterans'
27 Aid Fund shall be expended for the purpose of organizing and maintaining
28 any veterans organization. There shall be expended under the direction of
29 the Director of Veterans' Affairs ~~director~~ such sum or sums as may be
30 specifically appropriated by the Legislature for the employment of
31 necessary assistants or deputies and clerical employees at such

1 reasonable compensation as may be fixed by the director in each
2 particular case and for the maintenance and expenses of a state service
3 office with necessary service officers and assistants to prepare and
4 present meritorious cases of ex-servicemen and ex-servicewomen for
5 benefits before the United States Department of Veterans Affairs. Such
6 cases shall be accepted by the state service officer on behalf of any
7 claimant when a proper power of attorney is given by such claimant to the
8 office of the Director of Veterans' Affairs ~~director~~ or to a state
9 service officer, if he or she is so designated by any recognized veterans
10 organization as its sole representative, and regardless of where the
11 cases originate. No part of such sum or sums is to be paid out of the
12 twelve-million-dollar trust fund or the income therefrom. Upon the
13 completion of the trust, the principal fund so held by the State
14 Treasurer shall revert to the treasury of the state.

15 (4) For purposes of this section, veteran means any person who:

16 (a) Served on active duty in the armed forces of the United States,
17 other than active duty for training, and who:

18 (i) Was discharged or otherwise separated with a characterization of
19 honorable or general (under honorable conditions) from such service; or

20 (ii) Died while in service or as a direct result of such service; or

21 (b) Being a citizen of the United States at the time of his or her
22 entry into such service, served with the military forces of any
23 government allied with the United States during any period identified in
24 section 80-401.01 and was discharged or otherwise separated with a
25 characterization of honorable or general (under honorable conditions).

26 Sec. 3. Section 80-401.11, Reissue Revised Statutes of Nebraska, is
27 amended to read:

28 80-401.11 Suitable offices shall be provided for the Department of
29 Veterans' Affairs. ~~The department in the State Capitol. It may maintain~~
30 ~~necessary offices at such other places in the state as it may designate~~
31 ~~and~~ may incur the necessary expense for office furniture, stationery,

1 printing and other incidental or necessary expenses and ~~It may~~ employ
2 such clerical and other employees and assistants as the department deems
3 ~~it may deem~~ necessary for the proper transaction of its business.

4 Sec. 4. Section 80-411, Revised Statutes Cumulative Supplement,
5 2022, is amended to read:

6 80-411 (1) If the requirements of subsection (2) of this section are
7 met, the University of Nebraska, the state colleges, and the community
8 colleges shall waive the following for a dependent of a veteran:

9 (a) All tuition; and

10 (b) All fees remaining due after subtracting awarded federal
11 financial aid grants and state scholarships and grants.

12 (2) A person shall be eligible for the waiver of tuition and such
13 fees if he or she meets the following requirements:

14 (a) He or she is a resident of this state and meets the appropriate
15 institution's requirements for establishing residency for the purpose of
16 paying instate tuition;

17 (b) He or she has a parent, stepparent, or spouse who was a member
18 of the armed forces of the United States and who:

19 (i) Died of a service-connected disability;

20 (ii) Died subsequent to discharge as a result of injury or illness
21 sustained while a member of the armed forces which may or may not have
22 resulted in total disability;

23 (iii) Is permanently and totally disabled as a result of military
24 service. Permanent and total disability does not include total ratings or
25 other temporary ratings except total ratings based on individual
26 unemployability if permanent; or

27 (iv) While a member of the armed forces of the United States, is
28 classified as missing in action or as a prisoner of war during armed
29 hostilities; and

30 (c) If he or she is a child or stepchild of a person described in
31 subdivision (2)(b) of this section, he or she is under the age of twenty-

1 six years unless he or she serves on active duty with the armed forces
2 after his or her eighteenth birthday but before his or her twenty-sixth
3 birthday, in which case such period shall end five years after his or her
4 first discharge or release from such duty with the armed forces, but in
5 no event shall such period be extended beyond the thirty-first birthday.

6 (3) An application for a waiver shall be submitted on a form to be
7 prescribed by the Director of Veterans' Affairs.

8 (4) If the Director of Veterans' Affairs or the director's designee
9 ~~director~~ determines that the applicant is eligible for the waiver, the
10 director or the director's designee shall so certify to the institution
11 in which the applicant desires to enroll. The decision of the director or
12 the director's designee shall, in the absence of fraud or
13 misrepresentation on the part of the applicant, be final and shall be
14 binding upon the applicant and upon the institutions specified in this
15 section. The director shall adopt and promulgate reasonable rules and
16 regulations for the administration of this section.

17 (5) The waiver shall be valid for one degree, diploma, or
18 certificate from a community college and one baccalaureate degree.
19 Receipt of such degree, diploma, or certificate from a community college
20 shall precede receipt of such baccalaureate degree.

21 Sec. 5. Section 80-412, Reissue Revised Statutes of Nebraska, is
22 amended to read:

23 80-412 The Director of Veterans' Affairs shall make and preserve by
24 counties a permanent registry of the graves of all persons who shall have
25 served in the armed forces of the United States and whose mortal remains
26 rest in Nebraska. The county veterans service officer of each county
27 shall be charged with securing the information requested by the director
28 ~~Director of Veterans' Affairs~~ of every person having a service record
29 buried in that county and immediately forwarding such information to the
30 office of the Director of Veterans' Affairs ~~director~~. Such information
31 shall be secured from the undertaker in charge of the burial and shall be

1 transmitted by him or her to the county veterans service officer of the
2 county where burial is made and shall be recorded alphabetically and by
3 description of location in the cemetery where buried, in a method book as
4 prescribed by the director and kept for that purpose in the office of the
5 county veterans service officer.

6 Sec. 6. Section 81-1316, Revised Statutes Cumulative Supplement,
7 2022, is amended to read:

8 81-1316 (1) All agencies and personnel of state government shall be
9 covered by sections 81-1301 to 81-1319 and shall be considered subject to
10 the State Personnel System, except the following:

- 11 (a) All personnel of the office of the Governor;
- 12 (b) All personnel of the office of the Lieutenant Governor;
- 13 (c) All personnel of the office of the Secretary of State;
- 14 (d) All personnel of the office of the State Treasurer;
- 15 (e) All personnel of the office of the Attorney General;
- 16 (f) All personnel of the office of the Auditor of Public Accounts;
- 17 (g) All personnel of the Legislature;
- 18 (h) All personnel of the court systems;
- 19 (i) All personnel of the Board of Educational Lands and Funds;
- 20 (j) All personnel of the Public Service Commission;
- 21 (k) All personnel of the Nebraska Brand Committee;
- 22 (l) All personnel of the Commission of Industrial Relations;
- 23 (m) All personnel of the State Department of Education;
- 24 (n) All personnel of the Nebraska state colleges and the Board of
25 Trustees of the Nebraska State Colleges;
- 26 (o) All personnel of the University of Nebraska;
- 27 (p) All personnel of the Coordinating Commission for Postsecondary
28 Education;
- 29 (q) All personnel of the Governor's Policy Research Office;
- 30 (r) All personnel of the Commission on Public Advocacy;
- 31 (s) All agency heads;

1 (t)(i) The Director of Behavioral Health of the Division of
2 Behavioral Health; (ii) the Director of Children and Family Services of
3 the Division of Children and Family Services; (iii) the Director of
4 Developmental Disabilities of the Division of Developmental Disabilities;
5 (iv) the Director of Medicaid and Long-Term Care of the Division of
6 Medicaid and Long-Term Care; and (v) the Director of Public Health of the
7 Division of Public Health;

8 (u) The chief medical officer established under section 81-3115, the
9 Administrator of the Office of Juvenile Services, and the chief executive
10 officers of the Beatrice State Developmental Center, Lincoln Regional
11 Center, Norfolk Regional Center, Hastings Regional Center, Central
12 Nebraska Grand Island Veterans' Home, Norfolk Veterans' Home, Eastern
13 Nebraska Veterans' Home, Western Nebraska Veterans' Home, and each youth
14 rehabilitation and treatment center;

15 (v) The chief executive officers of all facilities operated by the
16 Department of Correctional Services and the medical director for the
17 department appointed pursuant to section 83-4,156;

18 (w) All personnel employed as pharmacists, physicians,
19 psychiatrists, or psychologists by the Department of Correctional
20 Services;

21 (x) All personnel employed as pharmacists, physicians,
22 psychiatrists, psychologists, service area administrators, or facility
23 operating officers of the Department of Health and Human Services or the
24 Department of Veterans' Affairs;

25 (y) Deputies and examiners of the Department of Banking and Finance
26 and the Department of Insurance as set forth in sections 8-105 and
27 44-119, except for those deputies and examiners who remain in the State
28 Personnel System;

29 (z) All personnel of the Tax Equalization and Review Commission; and

30 (aa) The associate director of the Conservation Division of the
31 Nebraska State Historical Society and all personnel employed as a

1 Conservator I or Conservator II of the Conservation Division of the
2 Nebraska State Historical Society.

3 (2) At each agency head's discretion, up to the following number of
4 additional positions may be exempted from the State Personnel System,
5 based on the following agency size categories:

8	less than 25	0
9	25 to 100	1
10	101 to 250	2
11	251 to 500	3
12	501 to 1000	4
13	1001 to 2000	5
14	2001 to 3000	8

18 The purpose of having such noncovered positions shall be to allow
19 agency heads the opportunity to recruit, hire, and supervise critical,
20 confidential, or policymaking personnel without restrictions from
21 selection procedures, compensation rules, career protections, and
22 grievance privileges. Persons holding the noncovered positions shall
23 serve at the pleasure of the agency head and shall be paid salaries set
24 by the agency head. An agency with over five thousand employees shall
25 provide notice in writing to the Health and Human Services Committee of
26 the Legislature when forty noncovered positions have been filled by the
27 agency head pursuant to this subsection.

28 (3) No changes to this section or to the number of noncovered
29 positions within an agency shall affect the status of personnel employed
30 on the date the changes become operative without their prior written
31 agreement. A state employee's career protections or coverage by personnel

1 rules and regulations shall not be revoked by redesignation of the
2 employee's position as a noncovered position without the prior written
3 agreement of such employee.

4 Sec. 7. Original sections 80-401.03, 80-401.11, and 80-412, Reissue
5 Revised Statutes of Nebraska, and sections 80-315, 80-411, and 81-1316,
6 Revised Statutes Cumulative Supplement, 2022, are repealed.

7 Sec. 8. The following section is outright repealed: Section 80-336,
8 Revised Statutes Cumulative Supplement, 2022.
