

## LEGISLATIVE BILL 101

Approved by the Governor February 11, 1971

Introduced by Fern Hubbard Orme, 29th District; Donald Elrod, 35th District; Willard H. Waldo, 31st District

AN ACT to amend section 39-1108, Reissue Revised Statutes of Nebraska, 1943, relating to the State Highway Commission; to remove the requirement that regular meetings be held in the State Capitol; and to repeal the original section.

Be it enacted by the people of the State of Nebraska,

Section 1. That section 39-1108, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

39-1108. Regular meetings of the State Highway Commission shall be held monthly. Special meetings may be held upon call of the chairman, or pursuant to a call signed by three other members, of which the chairman shall have three days written notice. All regular meetings shall be held in suitable offices to be provided in ~~the State Capitol~~ Lincoln. Four members of the commission shall constitute a quorum for the transaction of business. Every act of a majority of the members of the commission shall be deemed to be the act of the commission. All meetings shall be open to the public. The minutes of the meetings shall show the action of the commission on matters presented. The minutes shall be open to public inspection.

Sec. 2. That original section 39-1108, Reissue Revised Statutes of Nebraska, 1943, is repealed.

## LEGISLATIVE BILL 103

Approved by the Governor February 13, 1971

AN ACT to amend sections 79-1282 and 79-1283, Revised Statutes Supplement, 1969, relating to education; to clarify procedures of the Professional Practices Commission and the State Board of Education with regard to standards for the teaching profession; and to repeal the original sections.

Be it enacted by the people of the State of Nebraska,

Section 1. That section 79-1282, Revised Statutes Supplement, 1969, be amended to read as follows:

79-1282. The State Board of Education, with the counsel of the commission, shall develop, through the teaching profession, criteria of professional practices in areas including but not limited to: (1) Ethical and professional performance, (2) competency, (3) continuance in professional service, and (4) contractual obligations. The standards established under the provisions of this act shall be the generally accepted standards within the teaching profession with respect to competent performance and ethical practices.

Sec 2. That section 79-1283, Revised Statutes Supplement, 1969, be amended to read as follows:

~~79-1283. The standards established under the provisions of this act by the State Board of Education shall be the generally accepted standards within the teaching profession with respect to competent performance and ethical practices. The commission may warn and reprimand members of the teaching profession.~~ The State Board of Education shall request the commission or a special committee of members thereof to make investigations, hold hearings and make recommendations to the State Board of Education concerning alleged violations of standards of professional ethics and practices. The commission shall make recommendations shall be made a part of the record of the State Board of Education on in all cases of revocation or suspension of a certificate. The commission may privately admonish, warn and reprimand

members of the teaching profession for violation of the standards established pursuant to section 79-1282.

Sec. 3. That original sections 79-1282 and 79-1283, Revised Statutes Supplement, 1969, are repealed.
