#### INTRODUCTION

The Nebraska Legislature passed LB 157 in February 2008. The bill decriminalized child abandonment if a parent or guardian left a child at a hospital. After the law took effect in July 2008, 36 children and teenagers were left at Nebraska hospitals; no infants were left. The stories that emerged from these events made it clear that the state lacked adequate, effective services for families trying to deal with children's behavioral and mental health problems. Accordingly, the Governor called the Legislature into special session in November 2008. Senators changed the law so that it applied only to infants, but they also began discussions in earnest with the executive and judicial branches on Nebraska's juvenile mental and behavioral health system. In the 2009 legislative session, senators introduced a number of bills to provide and expand services. Those bills or amended versions of them were bundled together in LB 603, which the Legislature passed May 22, 2009.

LB 603 included the Children and Family Behavioral Health Support Act. The act created the Children's Behavioral Health Oversight Committee and authorized the Executive Board of the Legislative Council to appoint members of the Legislature to serve on the committee as follows: (a) Two members of the Appropriations Committee, (b) two members of the Health and Human Services Committee, (c) two members of the Judiciary Committee, and (d) three members of the Legislature who are not members of such committees (at-large). The committee terminates on December 31, 2011. *LB* 603, Sec. 11 (1)

The committee met July 17, 2009 and elected Senator Campbell to serve as chairperson and Senator Dubas to serve as vice-chairperson.

#### **COMMITTEE RESPONSIBILITIES**

The committee is to monitor the effect of implementation of the Children and Family Behavioral Health Support Act and other child welfare and juvenile justice initiatives by the Department of Health and Human Services related to the provision of behavioral health services to children and their families. *LB 603, Sec. 11 (2)*

Program <u>evaluation</u> :	LB 603 requires the Department of Health and Human Services to evaluate the Children and Family Support Hotline program, the Family Navigator Program, and post-adoption and post-guardianship services.

The committee is also required to meet at least quarterly with representatives of the Division of Behavioral Health and the Division of Children and Family Services of the Department of Health and Human Services and with other interested parties and may meet at other times at the call of the chairperson. *LB 603, Sec. 11 (3)* 

Finally, the committee is required to provide a report to the Governor and the Legislature no later than December 1 of each year. The report shall include, but not be limited to, findings and recommendations relating to the provision of behavioral health services to children and their families. *LB 603, Sec. 11 (5)* 

# **COMMITTEE FINDINGS AND RECOMMENDATIONS**

LB 603 programs are only recently operative, have been expanded only recently, or are not operative until January 1, 2010. Therefore the Children's Behavioral Health Oversight Committee has no findings or recommendations in this initial report to the Governor and the Legislature.

# STATUS OF PROGRAM CONTRACTS

Post-adoption and post-guardianship services

• The Department of Administrative Services has contracted with Lutheran Family Services to provide these services, which are to be operative no later than January 1, 2010. *LB 603, Sec. 8* 

Children and Family Support Hotline and Family Navigator Program

• The Department of Administrative Services has contracted with Boys Town to provide these programs, which are to be operative no later than January 1, 2010.

Program evaluation for post adoption/guardianship services, Children and Family Support Hotline, and Family Navigator Program

• The Department of Administrative Services has issued a letter of intent to contract with Hornby Zeller Associates, Inc. A protest has been filed. As of November 24, 2009, the contract has been delayed while protests are heard.

Professional Partner Program basic contracts with the state's behavioral health regions have been amended as follows to expand services (Regions 1, 2, 3, 4) or create pilot programs (Regions 5 and 6):

- Region 1: \$25,662
- Region 2: \$30,105
- Region 3: \$65,731
- Region 4: \$61,958
- Region 5: \$121,475
- Region 6: \$195,069

#### **COMMITTEE MEETINGS**

Three orientation meetings were scheduled in the fall of 2009: September 11, October 23, and November 20. Because the Legislature was meeting in special session in November, the November 20 meeting was postponed until December 14. All three meetings were open to the public. Since the goal was to provide as much background and discussion time as possible for committee members, public comments were scheduled for the November 20 meeting only (subsequently postponed until December 14), and were also welcomed at any time via e-mail to committee members.
