## ADDITIONAL STAKEHOLDER AND PUBLIC ENGAGEMENT SUMMARY

#### INTRODUCTION

Outside of the Visioning Workshop conducted in August 2022, the Project Team utilized several methods to conduct engagement with residents and stakeholders of North and South Omaha. These methods were designed to inform the public of project progress, present opportunities to engage with the project, inform the public of relevant funding opportunities created through the Economic Recovery Act Bill, and provide technical assistance to facilitate the generation of project applications. The primary methods are detailed as follows and include communication tools and methods, stakeholder meetings, public hearings and information sessions, and technical assistance.

#### COMMUNICATION

As part of LB1024 public engagement, the Project Team worked to foster clear and regular communication with stakeholders and members of the public. The team utilized several tools and resources to facilitate this communication, including personal stakeholder outreach, email newsletters, press releases, and the LB1024 project website. These tools provided information including project progress, engagement opportunities, submission details, and related updates.

#### **STAKEHOLDER OUTREACH**

Stakeholders were identified and contacted by the Project Team with the intent of fostering dialogue within the community and creating public awareness about the legislation and subsequent funding availability. Identified stakeholders were contacted through email notifications and were invited to participate in the Visioning Workshop that took place August 15-16, 2022. Stakeholders also had the opportunity to engage with the project through the communication tools listed as follows.

#### **EMAIL NEWSLETTERS**

The Project Team distributed information through email newsletters that contained information about engagement opportunities, upcoming funding opportunities and submission details, and project progress. These newsletters served as quick notifications of project progress and opportunities to participate in the process. As the project progressed, the email newsletter distribution list grew to include visioning workshop participants, stakeholder meeting and public hearing and information session attendees, proposal applicants, and others who asked to be informed of the progress of the project.

The **Economic Recovery Act**, enacted with the passage of Legislative Bill 1024 (LB1024) by the Nebraska State Legislature in 2022, provides at least \$335 million in funding to assist North Omaha, South Omaha, and other communities that were disproportionately impacted by the COVID-19 pandemic.

Funds under the Qualified Census Tract Recovery Grant program are intended to create sweeping economic growth through eligible uses such as **investment in employment**, **job creation**, **small business assistance**, **entrepreneurship**, **and housing**.

The goal of this funding is to foster **desirable transformation**, **fundamental change**, **and long-lasting economic growth** in the communities of North and South Omaha.

#### **PRESS RELEASES**

Formal communication was distributed through press releases originating from the office of Senator Justin Wayne, Chairperson of the Economic Recovery Special Committee of the Legislature. These press releases contained information related to the Economic Recovery Act Bill, the allocation of funding, stakeholder and public engagement opportunities, and other relevant information. Two releases, that announced the public information schedule and submission process, were distributed on August 31 2022, and September 18, 2022.



#### **PROJECT WEBSITE**

One of the key communication tools utilized as part of the LB1024 efforts was the project website, which can be found at **www.omahaeconomicrecovery.com**. The website hosted information related to all aspects of the public engagement process, as well as information related to the purpose of the project, the Economic Recovery Act Bill, and Frequently Asked Questions. Website visitors were also able to book virtual technical assistance appointments with members of the Project Team and submit proposal applications. The website served as the primary method of communication with stakeholders and the public throughout much of the project.



#### STAKEHOLDER MEETINGS

During the development of the Coordination Plan (Plan), two stakeholder meetings were held at various stages to share the status of the Plan and address specific questions by the stakeholder groups. Each of the stakeholder meetings were organized by the stakeholder group and members of the Project Team were invited to provide an update on the project.

#### **GREATER OMAHA CHAMBER STAKEHOLDER MEETING**

On September 14, 2022, the Greater Omaha Chamber coordinated a meeting with approximately 25 small business Chamber members from North and South Omaha. Members of the Project Team were available to provide a preview of the upcoming public hearings and information sessions, including an overview of Coordination Plan development process, proposal application process, and proposal evaluation criteria.

#### PHILANTHROPIC COMMUNITY STAKEHOLDER MEETING

On November 18, 2022, the Omaha philanthropic community organized a meeting of approximately 12 organizations. The purpose of the meeting was to learn about the development of the Coordination Plan and associated activities that had occurred to date, including an overview of the Visioning Workshop and findings, public hearing and information sessions, and the proposal submission and evaluation criteria and process. Members of the Project Team were on hand to share information and answer questions.

#### PUBLIC HEARINGS AND INFORMATION SESSIONS

Joint public hearings and information sessions were held the week of September 19 in North and South Omaha. At each session, participants were able to learn about the project, ask questions of the Project Team, and provide formal testimony to members of the Legislative Special Committee. The public was notified of the joint public hearings and information sessions through press releases issues by Senator Wayne's office and via the project website.

#### **PROCESS AND LAYOUT**

Each of the joint public hearing and information sessions used a similar format and layout of information. The space was split into three parts, each with a different purpose. The first area contained the information session portion that was hosted in an open house format with posters staffed by Project Team members. Four hundred twenty-nine people signed into the information session. The goal of this area was to provide general information about the project and process and answer individual questions from attendees. Station content included:

In the second area, engineers, architects and planners from the Project Team and Omaha city staff members hosted informal technical assistance discussions with attendees who wanted feedback and additional information about the technical aspects of their project proposals. Full details on technical assistance can be found in the next section.

In the third area, attendees were able to provide formal testimony to members of the Legislative Special Committee. Those providing testimony spoke about how they felt the Special Committee should allocate the funding in the Coordination Plan. Some testimony was general in nature; however, most spoke specifically about needs in the community and their proposal to address those needs. There were 77 people who provided formal testimony.

#### **TECHNICAL ASSISTANCE**

#### **OVERVIEW AND PURPOSE**

To foster more equitable access to the Economic Recovery Act Bill funding, the Project Team created a forum for the development of project ideas designed to assist potential applicants with some of the technical elements of their proposals to bolster their potential success. Technical assistance was offered to potential project applicants in person at the information sessions and online following the sessions. This assistance was provided by individuals equipped with knowledge of engineering, planning, architecture, and related technical fields.

#### LOGISTICS

Technical assistance opportunities at the information sessions were offered in person on a first come, first served basis. Notification of virtual technical assistance opportunities was distributed to individuals who attended the Visioning Workshop sessions, public meeting, or subscribed for project updates via Mailchimp email on September 29, 2022.

To register for a virtual technical assistance session, individuals signed up through the project website.

Technical assistance was provided on September 30, 2022, and October 3-7, 2022, generally from 8:00 a.m. to 7:00 p.m. each day. Each session was held using Zoom and was one hour.

#### PROCESS

Each technical assistance session began with introductions followed by conversation and questions generally led by the potential proposal applicant. Questions included a wide range of topics such as zoning, building rehabilitation, site development, cost estimating, proposal submission process, and proposal evaluation criteria.

In addition to the individual technical assistance sessions, Spark, a community-based organization focused on transforming disinvested Omaha neighborhoods into thriving and prosperous communities, convened a group of members of their developer academy to learn about the development of the Coordination Plan. Project Team members provided an overview of the program, proposal submission process and evaluation criteria, and offered technical assistance. Approximately 25 people were in attendance on September 29, 2022.

A technical assistance session was also held with Creighton University staff members on October 4, 2022, with six people in attendance.

#### ATTENDANCE

Approximately 20 people attended the in-person technical assistance opportunities during the information sessions. In addition, a total of 49 technical assistance sessions were held online.


