#### EXECUTIVE BOARD POLICY

#### **Executive Board Referral**

- A. As a general practice, the Executive Board will refer interim study resolutions to the appropriate committees based upon subject matter jurisdiction.
- B. Resolutions that call for the creation of a select committee will be reviewed by the Executive Board. Depending upon the availability of staff resources, subject matter jurisdiction, and legislator interest, the Executive Board may establish a select committee to undertake the study.
- C. The Executive Board shall retain its traditional prerogatives to consider and refer study proposals arising from extraordinary circumstances after the deadlines.

#### **Committee Action**

Legislative rules (Rule 4, Section 3(c)) require study resolutions be prioritized by the chairperson of the committee to which they are referred, and a report on those priorities shall be filed with the Clerk. Each committee shall file with the Clerk, his or her committee's study plan for the highest prioritized interim studies referenced to such committee. This prioritization will in no way limit the committee's traditional prerogative to conduct hearings and oversee matters that are within their subject matter jurisdiction.

Rule 4, Section 3(g) of the Rules of the Nebraska Unicameral Legislature requires that on or before December 1 of each year, each standing and select interim committee file a report on the disposition of the study resolutions referred to them.

AHEC's partner with the Rural Health Education Network which is funded by the Legislature, but AHEC's are federally funded through Title VII of the Public Health Service Act for a maximum of twelve years. The twelve-year period for federal funding for Nebraska's AHEC's will begin to expire in September of 2007 and all AHEC's will be off of federal funding in September of 2011.

This study shall determine the importance of AHEC's in maintaining easily accessible health services in underserved areas of Nebraska, recruitment and training of health professionals, continuing education for health professionals, and partnerships with other agencies with similar goals.

In addition, the study should determine whether AHEC services in Nebraska should be funded by the Legislature as federal funding expires.

The grain industry has been and continues to be concerned that transactions that are lawfully exempt from licensing and regulatory requirements could potentially lead sellers of grain to mistakenly believe that they are fully protected by current state regulation and bond coverage. For example, in 2005, more than fifty-five percent of first purchasers were exempt from Public Service Commission licensing and bonding authority. This study would examine the feasibility of requiring these purchasers to issue a statement to sellers that they are not required under Nebraska law to be

licensed or bonded.

- (1) The Grain Warehouse Division of the Public Service Commission (PSC) is charged with regulating the state-licensed grain warehouse and grain dealer laws. While the PSC conducted a series of hearings with producers, grain industry representatives, and other stakeholders over the last three years to review the grain laws and explore whether the current scope of regulatory protection available to owners, depositors, and sellers of grain is adequate, the PSC has admitted that staffing restrictions and budget considerations make it less likely that state-licensed warehouse inspections or grain dealer investigations can be conducted every nine months, or in a timely manner. The Nebraska grain warehouse industry and grain dealers have actively participated over the past two years in these hearings and supported a number of important and positive changes to the state grain laws in LB 735, Ninety-eighth Legislature, First Session, 2003, that offer substantially greater safeguards for producers and depositors at state-licensed warehouses:
- (2) The Budget, Finance and Personnel Division of the Department of Agriculture is already charged with collecting, randomly monitoring, and auditing the mandatory commodity or ethanol check-off programs from all first purchasers of Nebraska grain. In addition to random check-off audits by the Budget, Finance and Personnel Division, the Division of Weights and Measures, the Bureau of Plant Industry, and the Agriculture Laboratories Division of the Department of Agriculture also conduct annual inspections for and at state-licensed grain warehouses; and
- (3) Administrators, lawmakers, and private industry representatives have continually encouraged a dialogue for making government more efficient by combining similar regulatory activities under the same agency, and to explore streamlining or better coordination of existing services provided by various state agencies such as agriculture and agribusiness through personnel cross-utilization.

- (6) Review of the use of medical or hardship parole in the State of Nebraska.

PURPOSE: The purpose of this study is to evaluate the implementation of the new Nebraska Liquor Control Commission rule regarding acceptable forms or means of payment between retail licensees and wholesale licensees for purchases of alcoholic beverages (Title 237, Chapter 6, 015.05). The new rule, effective November 28, 2005, allows a wholesale licensee to accept credit cards as a form of payment from a retail licensee. The study should consider the following:

- (1) Overall evaluation of the implementation of the new rule;
- (2) Reported abuses of the new rule by wholesale licensees or retail licensees; and
- (3) The number of wholesale licensees accepting credit cards as a form of payment and the ability of retail licensees to use credit cards as a form of payment for alcoholic beverages.

PURPOSE: To study issues surrounding the use of ignition interlock devices for persons who have been convicted of driving under the influence as proposed in LB 1169 (2006). Some of the items to be studied should include:

- (1) Study federal revocation period requirements for driving under the influence (DUI) necessary for state compliance with federal grant programs;
- (2) Study the feasibility of a graduated system of "hard time" revocation periods before ignition interlock devices can be installed;
- (3) Study the current statutes regarding fifteen-year and life suspensions and study the feasibility of installing ignition interlock devices during that period of time, including what would be the optimum "hard revocation" time before a person with a fifteen-year license on life suspension can be considered for approval of an ignition interlock device and how long that device must remain installed in their vehicle. Study the proper period of "hard time" revocation if a person refuses to submit to a chemical test;
- (4) Study the electronic abstracting process for DUI cases to determine if the Department of Motor Vehicles is receiving adequate information to allow probation orders for ignition interlock devices to be correctly enforced;
- (5) Study the courts' probation orders for ignition interlock devices and oversight of persons on probation with ignition interlock device orders to see if there are better ways for probationers to comply with such orders;
- (6) Study whether or not ignition interlock device orders should be mandatory in DUI sentences;
- (7) Study DUI employment permit statutes to see if uses of employment permits should be expanded, including, but not limited to, allowing drivers with revoked licenses to travel to court-mandated treatment programs and community service; and
- (8) Study the need for subsidized access to ignition interlock devices and determine who should manage such a program if it is deemed to be necessary.

Further integration and coordination of publicly and privately funded services and supports for persons with traumatic brain injury and their families is necessary for the more effective and efficient provision of such services and supports on behalf of such persons.

The purpose of a statewide immunization registry shall be to (1) collect, store, analyze, release, and report immunization data, (2) assure that necessary immunizations are provided and overimmunization is avoided, (3) assess immunization coverage rates, (4) determine areas of underimmunization and other epidemiological research for disease control purposes, (5) document that required immunizations have been provided as required for school or child care admission, and (6) accomplish other public health purposes as determined by the department.

Costs associated with administration of the statewide immunization registry shall be paid from cash funds, contract receipts, gifts, and grants. No general funds shall be used to pay such costs.

It is the goal of the study to determine what changes in our statutes, whether modifications of existing programs or new proposals, would best serve municipal economic development efforts in Nebraska.

The study will involve:

PURPOSE: The purpose of this study is to determine how the State of Nebraska can encourage private landowners to allow the general public to hunt, fish, and trap on their land.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Natural Resources Committee of the Legislature shall be designated to conduct an interim study to carry out the purposes of this resolution.
- 2. That the committee shall upon the conclusion of its study make a report of its findings, together with its recommendations, to the Legislative Council or Legislature.

## **LEGISLATIVE RESOLUTION 412.** Introduced by Erdman, 47; Friend, 10

PURPOSE: The purpose of this study is to examine whether the benefits of a unicameral system of state government set forth by George W. Norris and other advocates of unicameralism have been realized.

Unicameral advocates often state:

- (1) There is no reason for people to vote for representatives to two separate houses, both on the basis of population. The concept of "one person, one vote" has negated the original intent of having each house elected on a different basis;
- (2) The unicameral form simplifies bill passage. The process is more direct since the conference committee is eliminated. Bills are more subject to scrutiny by legislators and the public;
- (3) Lobbyists are less influential in the unicameral legislature because the lawmaking process is more public;
- (4) In a unicameral system, it is easier to achieve cooperation between executive and legislative branches;
  - (5) A unicameral system is more economical;
  - (6) A unicameral system provides greater responsibility to legislators; and

(7) Legislators are more accountable to the public and their constituency because their position is a matter of public record and they are not able to urge opposite positions within the other house.

Alternatively, bicameral advocates often state:

- (1) A bicameral legislature provides for more careful and deliberate consideration of legislation. Action of the two houses required for passage prevents bills from being quickly passed under the sway of emotion;
- (2) Many of the charges of shifting responsibility are exaggerated and ill-founded. A legislator who continually fails to accept responsibility would not be reelected;
- (3) Objectionable lobbying is not the major problem in the bicameral legislature that it is often assumed to be. Lobbyists can more easily promote desired legislation where control is needed in only one house;
- (4) Although bicameral state legislatures are not perfect, it would be easier to correct their flaws than to change their structure; and
- (5) Further consideration of legislation by another duly-elected body would assure more thoughtful action in passing bills.

This study shall include, but not be limited to, determining the advantages and disadvantages of a unicameral legislature compared to a bicameral legislature regarding such issues as efficiency, economy, effectiveness, organization, accountability, and responsiveness to voters.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

PURPOSE: The purpose of this study is to examine the creation of lumpsum staff salary budgets for state senators. The study will compare the current practice of determining the eligible starting salary with allowing senators the discretion to determine their staff salaries within an allocated budget.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Executive Board of the Legislative Council shall be designated to conduct an interim study to carry out the purposes of this resolution.

**LEGISLATIVE RESOLUTION 414.** Introduced by Erdman, 47; Johnson, 37.

PURPOSE: The purpose of this study is to review the status of public higher

education in Nebraska by examining the following specific questions to be answered by this study rather than focusing only on increasing student enrollment at these institutions:

- (1) What is the long-term sustainability of our current public higher education system in Nebraska?
- (2) How do the missions of our community colleges, state colleges, and university system link and what can be done to improve efficiencies within the Nebraska public higher education system?
- (3) How many colleges and university campuses should the state support based on present and future demographics of the state?
- (4) How should state public higher education institutions be coordinated and governed?
- (5) What proportion of tuition, private support, and tax dollars should be used to finance public higher education in Nebraska?
- (6) What should be the focus of legislation in the next decade regarding public higher education other than increasing student enrollment?

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Education Committee of the legislature shall be designated to conduct an interim study to carry out the purposes of this resolution.
- 2. That the committee shall upon the conclusion of its study make a report of its findings, together with its recommendations, to the Legislative Council or Legislature.

**LEGISLATIVE RESOLUTION 415.** Introduced by Erdman, 47; Fischer, 43; Kremer, 34; Schrock, 38; Wehrbein, 2.

PURPOSE: The purpose of this study is to examine and address issues associated with implementation of an animal identification program. The study shall specifically seek to identify the current level of voluntary participation of livestock owners in existing animal identification programs, to examine current and future options to increase livestock owners' participation in identification programs, to monitor the progress of the United States Department of Agriculture in developing a national animal identification program as well as to quantify the resource needs of the Nebraska Department of Agriculture to carry out any state components of such a program, and to identify costs to producers, markets, and other segments of the livestock industry.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Agriculture Committee of the Legislature shall be designated to conduct an interim study to carry out the purposes of this resolution.
- 2. That the committee shall upon the conclusion of its study make a report of its findings, together with its recommendations, to the Legislative Council or Legislature.

**LEGISLATIVE RESOLUTION 416.** Introduced by Erdman, 47; Flood, 19.

PURPOSE: The purpose of this resolution is to reexamine the effects of changing the age of majority from age 19 to age 18. This study should include, but not be limited to, examining the effects of this change to wards of the state. In 2003 and 2004, interim studies recommended statutory changes relating to the age of majority. The statutes covered by the committee amendment fell within the jurisdiction of multiple committees of the Legislature. This resolution proposes the Judiciary Committee serve as the lead committee in conducting this study. The legal counsels for the committees with subject matter covered by the study shall participate as staff in the conduct of the interim study.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Judiciary Committee of the Legislature shall be designated to conduct an interim study to carry out the purposes of this resolution.

## **LEGISLATIVE RESOLUTION 417.** Introduced by Erdman, 47.

PURPOSE: The purpose of this study is to examine the retirement system in place throughout Nebraska for peace officers. The study will compare the plans offered to peace officers employed in the political subdivisions of this state and to make a recommendation to the Legislature on the development of a plan to address the lack of retirement plans for peace officers employed by cities of the second class and villages and any shortfalls in peace officer retirement plans currently in place within the state. These plans could include, but not be limited to, the creation of a new defined benefit plan, the creation of a new defined contribution plan, or the possible inclusion of peace officers employed by cities and villages in the County Employees Retirement Act currently administered by the state.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Nebraska Retirement Systems Committee of the Legislature shall be designated to conduct an interim study to carry out the purposes of this resolution.
- 2. That the committee shall upon the conclusion of its study make a report of its findings, together with its recommendations, to the Legislative Council or Legislature.

#### **LEGISLATIVE RESOLUTION 418.** Introduced by Erdman, 47.

PURPOSE: The Legislature recognizes the importance of and economic impact that Interstate 80 has on the State of Nebraska, both to bring goods to the citizens of Nebraska and by providing goods and services to travelers from other states. The Legislature further recognizes that the vehicle towing and salvage industry plays an important role in providing services to travelers and for the safe operation of vehicles on the interstate.

The purpose of this study is to consider the steps that can be taken to

support and develop the vehicle service and towing industry in Nebraska. This study shall include, but not be limited to, reviewing Nebraska laws and the laws of other states relating to abandoned vehicles and salvage of vehicles and gathering information on the number of and the procedures for clearing damaged and abandoned vehicles. Input shall be solicited from the Nebraska State Patrol, academic professionals, the towing industry, the trucking industry, automobile associations, and any other government agencies, groups, or individuals with relevant information.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Transportation and Telecommunications Committee of the Legislature shall be designated to conduct an interim study to carry out the purposes of this resolution.
- 2. That the committee shall upon the conclusion of its study make a report of its findings, together with its recommendations, to the Legislative Council or Legislature.

#### **LEGISLATIVE RESOLUTION 419.** Introduced by Erdman, 47.

PURPOSE: In 1991, under the Intermodal Surface Transportation Efficiency Act (ISTEA), Nebraska's length law for combination vehicles was frozen at 65 feet. This issue has not been one that the grain warehouse industry or grain dealers have been concerned with until recently.

Today, grain elevators and producers alike are faced with serious transportation challenges, including sustained record fuel prices, hauling longer distances to terminal markets or processing facilities that offer better margins, and the lack of interest or capacity by Class One Railroads to efficiently haul grain by rail. In Nebraska, as well as nationally, well over fifty percent of all grain transported is hauled by truck instead of rail. The increasing truck traffic is adding a tremendous burden on our roads, challenging local and state government's ability to pay for and maintain adequate repairs, as well as making it more difficult to keep our highways safe.

States to the north and west of Nebraska maintained their longer truck lengths under the 1991 act. Each state varies on their laws and rules and regulations on operating these longer vehicles, however most have adopted the standards of 81 feet 6 inches on non-interstate roads to 110 feet on interstate highways. These extended lengths have added a major boost in the efficient transportation of grain, because these trucks can haul over one and one-half times the load of grain on the same tank of fuel.

Nebraska Beet Growers have benefitted for some time under a federal exemption that allows beet trucks to run at the 81 feet 6 inches length. In 2006, the custom harvesters obtained a federal exemption to allow the State of Nebraska the option, subject to a change in state law, to allow the operation of commercial vehicle combinations not exceeding 81 feet 6 inches for custom harvesters operating in Nebraska.

Therefor, the Transportation and Telecommunications Committee of the Legislature should conduct an interim study that invites the grain warehouse and feed industry, trucking industry, farm commodity organizations, and state and local government representatives to review all issues involved with, and the practicality for seeking a federal exemption extending the length of combination vehicles in Nebraska for the purposes of hauling corn, wheat, soybeans, sorghum, millet, dry beans, and any other grain as defined by law.

The interim study should also invite representatives from the Nebraska Department of Roads, the State Patrol, the Department of Motor Vehicles, the Department of Agriculture, and the Highway Safety Division of the Department of Motor Vehicles to examine all practical issues surrounding any combination vehicle extension in Nebraska and to examine applicable laws and rules and regulations in states already permitting extended lengths.

The interim study must place particular emphasis on public safety considerations. These safety considerations must include, but are not limited to, highway classification, road and weather conditions, speed limitations, and any other restrictions necessary for the safe and practical operation of extended combination vehicles.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Transportation and Telecommunications Committee of the Legislature shall be designated to conduct an interim study to carry out the purposes of this resolution.
- 2. That the committee shall upon the conclusion of its study make a report of its findings, together with its recommendations, to the Legislative Council or Legislature.

#### **LEGISLATIVE RESOLUTION 421.** Introduced by Bourne, 8.

PURPOSE: The purpose of the study is to review child custody proceedings and determinations. The study shall include an examination of the methods employed by the courts of this state in determining custody including, but not limited to, the option of joint custody and the utilization of mediation and family courts.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Judiciary Committee of the Legislature shall be designated to conduct an interim study to carry out the purposes of this resolution.

**LEGISLATIVE RESOLUTION 422.** Introduced by Louden, 49; Baker, 44; Connealy, 16; Cudaback, 36; Fischer, 43; Heidemann, 1; D. Pederson, 42

PURPOSE: The purpose of this interim study is to study Nebraska's hospital districts' access to property tax revenue in the years since the statutorily-imposed limits on property tax levies took effect in 1998.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the Revenue Committee of the Legislature shall be designated to conduct an interim study to carry out the purposes of this resolution.
- 2. That the committee shall upon the conclusion of its study make a report of its findings, together with its recommendations, to the Legislative Council or Legislature.

## LEGISLATIVE RESOLUTION 423. Introduced by Landis, 46.

PURPOSE: The purpose of this study is to continue and improve work done by the Revenue Committee of the Legislature during past interims to inform the Legislature and other interested parties of Nebraska's tax structure compared with the past and with other states. Carrying out the purposes of this study does not involve conducting public hearings, but should result in one or more reports to the Legislature detailing Nebraska's tax structure. Examples of reports conducted pursuant to this study would include the base and rates of Nebraska's sales, income, property, excise, and miscellaneous taxes in comparison to the past or to other states; spending by the state and local governments compared to that of governments in other states; the effectiveness of tax reform legislation enacted in the past; and financial and tax policy implications of tax reform or restructuring proposals that have been proposed during recent legislative sessions or arise during this interim. This study shall be directed toward gathering information that will assist the Legislature in training new members of the Legislature and their staff, and in evaluating the State of Nebraska's tax structure in future years.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

- 1. That the staff of the Revenue Committee of the Legislature conduct research and coordinate research conducted by other employees of the Legislative Council or other parts of state government to carry out the purposes of this study.

#### **LEGISLATIVE RESOLUTION 424.** Introduced by Landis, 46.

PURPOSE: The purpose of this interim study is to examine the possibility of negotiating a fuel tax agreement between the state and the Ponca Tribe of Nebraska that would be similar to the agreements negotiated with other Nebraska tribes with motor vehicle fuel stations in the state. The study should discuss issues including, but not limited to, the location of any such motor vehicle fuel station and the appropriate use of any revenue that would be returned to the Ponca Tribe under such an agreement.

# **LEGISLATIVE RESOLUTION 438.** Introduced by Dw. Pedersen, 39; Synowiecki, 7.

PURPOSE: The purpose of this study is to examine personnel issues surrounding a proposed merger of the offices of probation and parole administration under the executive branch or under the Supreme Court. The study should include the following:

- (1) Evaluation of Supreme Court employees' lack of collective bargaining rights under the State Employees Collective Bargaining Act and possible alternatives to collective bargaining to provide equitable employment rights to Supreme Court employees;
- (2) Analysis of Supreme Court employee salaries with similarly situated positions in neighboring states, including a comparative ranking of judges and probation officer salaries to judges and probation officer salaries in nearby states;
- (3) Evaluation of the collective bargaining rights granted to parole officers under the State Employees Collective Bargaining Act; and
- (4) Evaluation of any potential impact a Supreme Court merger may have on parole officer collective bargaining rights.

PURPOSE: The purpose of this interim study is to examine the constitutional issues raised by provisions of LB 1249 introduced in the Ninety-ninth Legislature, Second Session, 2006, including:

- (1) Does the awarding of exclusive service territories to natural gas providers at retail constitute the granting of a franchise in violation of Article III, section 18, of the Constitution of Nebraska?
- (2) Does the awarding of exclusive service territories without compensation to the State of Nebraska constitute the granting of a special or exclusive privilege prohibited by Article III, section 18, of the Constitution of Nebraska?
- (3) Does the granting of exclusive service territories without providing a mechanism for revocation, suspension, or lapse, constitute an irrevocable grant of special privileges in violation of Article I, section 16, of the Constitution of Nebraska?
- (4) Does the establishment of exclusive service territories prohibit municipalities from enforcing current or future contractual rights, arising from existing franchises, in violation of Article I, section 16, of the Constitution of Nebraska, dealing with impairment of contracts?
- (5) Does the forced transfer by the Public Service Commission of property as between public and private utilities without a mechanism to determine value or compensation violation the due process clause of Article I, section 3, of the Constitution of Nebraska?

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NINETY-NINTH LEGISLATURE OF NEBRASKA, SECOND SESSION:

1. That the Judiciary Committee and the Urban Affairs Committee of the Legislature shall be designated to jointly conduct an interim study to carry out the purposes of this resolution.

- (1) The interests and desires of the public on this issue, including the history of enactment of the State Lottery Act;
- (2) Allocation of state lottery and other revenue for natural resources conservation and reclamation in other states; and
- (3) Any other matters necessary or appropriate for a complete examination of this issue.
